This partnership enables Fund Channel to deliver one of the leading platform solutions proposed to asset managers and distributors, through fully-fledged dealing and distribution services capitalizing on the strength and expertise of its two shareholders.

This milestone is part of both parties' 2025 strategic plan, as communicated to investors in June 2022, with an objective of EUR 600 bn of Assets under Administration. Fund Channel offers services for the open-architecture distribution market in Europe, including data management, fund execution, advisory services, business intelligence, and rebates management, with the #1 quality position on the platform market¹
